
The Departmental Examinations under Sindh Civil Servants (Departmental Examinations Rules 1978 to be held in the month of December, 2017/January, 2018 at Head Office, Sindh Public Service Commission, Thandi Sarak, Hyderabad as per details given below.

02. Revenue Qualifying Departmental Examination (R.Q.E)
03. Forest Officer.

2) The above Examinations will be held on the basis of the Syllabus and the Rules applicable for the present Examination read with the Sindh Civil Servants (Departmental Examinations) Rules, 1978.

3) The candidates should send their particulars on the proforma through their Appointing Authority. **A challan of Rs: 500 (Rupees five Hundred Only)** duly paid under the Head of Account "C02101-Organ of State Examination Fee (Sindh Public Service Commission) Receipts" (in original) as Examination fee and three attested passport size photographs should also be enclosed with the application. The prescribed proforma, duly countersigned by the Competent Authority). Should reach the Commission's Office not later than **08-12-2017**. The candidates whose particulars are not received from the Department by prescribed date or they failed to unclosed required Challan of Examination fee duly paid in the correct head of Accounts, Shall not be admitted to the Examination.

- 4) If the Departmental Examinations contains two parts, separate Examination Fee of 500/- (Rupees Five Hundred Only) is to be paid for each part of the said Departmental Examination. The prior special permission for appearing in both parts of Examinations, simultaneously, is also essential for Admission in the second part.
- 5) The number of attempt made by the candidate previously with result thereof should clearly be indicated otherwise the application will not be entertained.
- 6) If a candidates, admitted in the Examination is unable to appear for any reason, he should send such intimation to the Additional Controller of Examinations, Sindh Public Service Commission, Hyderabad at least 07 days before the date of commencement of Examinations.
- 7) **NO APPLICATION SHALL BE ENTERTAINED, IF RECEIVED AFTER THE EXPIRY OF CLOSING DATE i.e 08- 12-2017.**
